<p><b>Non-Specific DNase Activity (16 Hour)</b> A 50 µl reaction in NEBuffer 2 containing 1 µg of T3 or T7 DNA in addition to a reaction containing Lambda-HindIII DNA and a minimum of 2 units of Vent® (exo-) DNA Polymerase incubated for 16 hours at 37°C results in a DNA pattern free of detectable nuclease degradation as determined by agarose gel electrophoresis.</p>	<b>Pass</b>
<p><b>qPCR DNA Contamination (E. coli Genomic)</b> A minimum of 2 units of Vent® (exo-) DNA Polymerase is screened for the presence of E. coli genomic DNA using SYBR® Green qPCR with primers specific for the E. coli 16S rRNA locus. <p><b>Protein Purity Assay (SDS-PAGE)</b> Vent® (exo-) DNA Polymerase is ≥ 95% pure as determined by SDS-PAGE analysis using Coomassie Blue detection.</p>	<b>Pass</b>
